- 1. To receive apologies for absence with notified reasons

Councillor Morgan sent his apologies. All agreed to accept.

2. To record Declarations of Interest from Councillors in any item to be discussed

3. To discuss the Field Planning application and formulate the Parish Council response.

The clerk read out an email from Highways which stated the following.

The Planning Application (2025/1689) for Field View at Great Moulton was presented. There was significant discussion, and it was resolved that the Highway Authority would issue a holding objection based on the following grounds:

- The proposed construction traffic route lacks sufficient width to safely accommodate two heavy goods vehicles (HGVs) simultaneously along the stretch from Flowerpot Lane to the site on Market Lane. A continuous carriageway width of six meters should be provided throughout this route. Additionally, forward visibility is notably restricted, particularly between Flowerpot Lane and Wacton.
- 2. The submitted information does not provide information on how vulnerable road users would be considered and impacted along the proposed route and information is required.

Until the above are addressed the highway authority will continue to object. We expect the applicant to begin negotiations with us, and we will keep you informed.

Thanks to Geoff and Keith for their work on three documents that will be submitted with our objections on 25th July 2025 by the locum clerk.

The documents that were missing have been redone and these will be submitted at the same time.

The locum clerk also commented that all the documents are on the website, and he was thanked for his work on this.
