Reported that he is strongly opposed to the National Grid East Anglia Green project and that an under sea option is the only alternative. Natural England have managed to stall all new build planning applications over concerns regarding nutrient neutrality.
 - 5.2 District Councillors Report . The purchase of a joint office with Broadland Council has been approved, with the preferred premises being Horizon House on Broadland Business Park. South Norfolk would have local hubs so that residents would be able to contact them if need be. South Norfolk Council are opposed to the National Grids East Anglia Green proposals as is our MP Richard Bacon who is lobbying accordingly. Cllrs raised questions to Mr Ridley about the costs of moving to Horizon House and the future use of South Norfolk House, DCllr Ridley said no plans had been discussed as yet though it is owned by South Norfolk Council.
